## Privacy Policy

This document contains the privacy practices for the Site. Circle Express Ltd takes its obligations to guard your privacy seriously. The purpose of this privacy policy is to inform you about the information that is collected about you, how Circle Express Ltd may use and disclose the information that is collected, and how information can be corrected or changed.

### **1. Information collected and use of information**

#### **I. Personal Information.**

From time to time, we may ask you to provide to us certain information, by which you may be identified, such as your name, title, addresses, telephone number, e-mail address and similar information. This information will be referred to in this document as "Personal Information". You may decline to provide this Personal Information, but may thereby be unable to participate in certain activities or opportunities offered on the Site.

##### **i. Collection of Personal Information and its use.**

From time to time, we may collect information from you - personal as well as non-personal - for internal use within the Circle Express Ltd group of companies. Any information collected may be shared among companies that are part of the Circle Express Ltd group of companies. Exceptionally, we may want to share your names and addresses with third party companies for marketing, research and other commercial use, but we will never do so without explicitly asking your consent. We may collect personal information directly from you through our Site when : 1) you sign up to receive newsletters and other information ; 2) you enter contests and participate on various activities featured on the Site. We also collect other information, such as tracking what pages you go to on the Site. This information is then used internally to tailor our products and services to suit your personal interests. We will not use Personal Information we collect from you for purposes other than those for which the information was collected, without asking for appropriate permission prior to such use.

### **2. Cookies and other technologies**

The Site uses "cookies". A cookie is a small amount of data that is sent to your browser from a web server and stored on your computer's hard drive. Generally, we use cookies to allow us to track your visits to our Site. The settings on most browsers allow you to control whether your computer will accept cookies from this Site or any other website. In addition, when you access the Site, we will log the IP address of your internet service provider in our web server logs. We may also collect related information such as browser type, operating system and pages visited in order to help us manage the Site.
